Implementation of Quality Management System (QMS) and Development of Quality Culture in Training Centers.

With reference to the Tertiary and Vocational Education Commission (TVEC) circular No. TVEC/08/91 dated 01 March 2016 and Ministry of Skills Development and Vocational Training circular No. MSDVT/SSDP/2016-1 dated 26 February 2016 (These circulars are published in TVEC website)

The (TVEC) has the national mandate to maintain the quality assurance of the Technical and Vocational education and Training (TVET) sector in Sri Lanka by the parliamentary Act No. 20 of 1990 and section 4(k) of the Act no 50 of 1999 as amended.

Due to various issues, training institutes were unable to maintain the QMS status during the past, thus making significant impact on the institutes' quality process. To overcome this situation, you are kindly informed that all the training institute those who are issuing NVQ L 5 & 6 certificates, installation and maintenance of QMS is compulsory with effect from 01 January 2025 for the Technical and Vocational Education and Training (TVET) sector. It is envisaged to make QMS compulsory for delivery of NVQ L 1-4 programmes with effect from 01 July 2025 onwards.
